Also the village of Torquay has been fined for \$42,000 over a workers death. The worker crawled into a pit to fix a water pump and was overcome by Hydrogen sulfide gas on March 11, 2014.

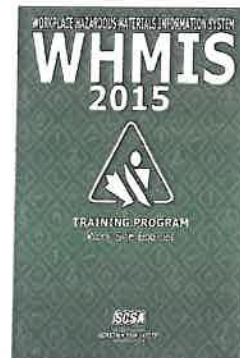

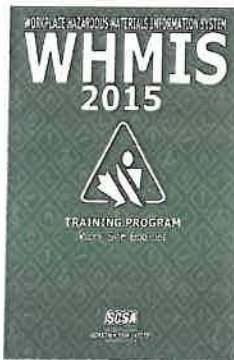
