NEW WHMIS 2015 AFTER GHS

On February 11, 2015, the Government of Canada modified the Workplace Hazardous Materials Information System (WHMIS) to incorporate the Globally Harmonized System (GHS) for classifying and labelling workplace chemicals. This modified WHMIS is referred to as "WHMIS 2015."

While the new system contains new international hazard classifications and labelling requirements, the responsibilities for workers, supervisors and suppliers will remain the same. Worksafe Sask is currently offering a free introductory course to WHMIS 2015 through the CCOHS.
