2.5.2 Can Sask Job Grant Presentation

Doug Rain from the Government of Saskatchewan discussed the parameters for the grant.

- If qualified the grant will cover two thirds and the employer pays the other one third.
- Employer must meet one of the three main requirements.
 - (1) A commitment to hire the new employee
 - (2) Create a new position for current employee.
 - (3) Contribute to an existing position that will better employee and employer.

After approval, employer will pay full cost and invoice for the two thirds rebate. Fifteen thousand is the training cap but some special circumstances can be considered. Public funded companies, temporary workers and apprenticeship courses are not eligible. Employer is responsible for any follow up training. Owners can be trained in some circumstances.

Eligibility

The Canada-Saskatchewan Job Grant is open to businesses and non-profits in Saskatchewan. The grant supports new investments in training and is not intended to replace an employer's existing investment in training. Training costs that are eligible for this grant include: tuition and mandatory student fees, textbooks, software and other required materials, and exam fees.

Cost Sharing

Employers invest one-third of training costs and gain the benefit of a worker who is skilled and ready to work. The Canada-Saskatchewan Job Grant will reimburse employers for the remaining two-thirds of eligible training costs. Employers may make multiple grant applications to a maximum of \$250,000 annually.

Program Features

Employer Driven: Employers decide on who gets training and what type of training may be needed for new and existing employees.

Shared Costs: Training costs are shared between the program and the employer.

Employment: You employ the trainee at the end of training.

How To Apply

- Visit economy.gov.sk.ca/job-grant to complete a pre-assessment checklist.
- Submit the completed checklist to your nearest Labour Market Services office to determine your eligibility.
- The Labour Market Services office will then work with you to complete a grant application.
