- Provide membership with quality safety advice and other assistance, which may include worksite inspections, worksite
 hazard identification, toolbox and safety meetings and implementation of safety programs.

Qualifications

Typically, the knowledge and skills required for this position would be obtained through completion of Grade 12 and/or related industry training of a minimum 100 hours (industry trade apprenticeship) and/or journeyperson status. As well as three (3) years of occupational health and safety experience (two years of which in the construction industry). Construction Safety Officer (CSO) designation or a related certificate in Occupational Health and Safety would be considered strong assets.
