

## Safety Training Technician

### About the Role

### Qualifications:

Typically, the knowledge and skills required for this position would be obtained through completion of post-secondary education in Adult Education, a minimum of three (3) years of experience in an adult education training environment and knowledge of occupational health and safety legislation and Workers' Compensation Board policy. Experience in the construction industry and/or Construction Safety Officer (CSO) designation would be considered an asset.

- Effective customer service, interpersonal and communication skills;
- Excellent planning and organizational skills, including the ability to prioritize and effectively manage time;
- Ability to work independently, within a team environment;
