Reporting to the Safety Advisor Manager, this role is located in Saskatoon. The incumbent will be expected to travel throughout Saskatchewan conducting site visits, presenting and educating on the importance of safety on a construction site. This is a great fit for someone who is passionate about safety, customer focused, has strong communication and interpersonal skills.

DUTIES AND RESPONSIBILITIES

- Provide effective marketing and delivery of programs and services to the membership including promoting safety education, site visits and inspections, toolbox talks, hazard assessments, best practices/procedures, orientations, and safety demonstrations.
- Provide quality service and advice to assigned Regional Safety Committees and members.
- Conduct safety and pre-audit inspections in conjunction with the Certificate of Recognition (COR) and Small Employer Certificate of Recognition (SECOR) programs when requested.
- Provide accurate and efficient delivery of safety training courses and presentations when requested including regional training.
- Assist members with the development of an effective health and safety program including health and safety manual development.
- Assist in evaluating course proficiencies and audits and reviewing safety training course material and programs when requested.
- Provide leadership on special group activities; attend meetings, functions, and special events.
- Perform other duties as assigned.

- Working on a construction site in a direct or similar capacity
